



NOTICE UNDER SECTION 708A(5)(E) OF THE CORPORATIONS ACT 2001 (CTH)

GTI Energy Ltd (ASX:GTR) (**Company**) gives notice for the purpose of section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) that, on 21 July 2025, it issued and allotted a total of 13,714,286 ordinary shares in the Company (**Securities**) without disclosure under Part 6D.2 of the Corporations Act.

The Securities are part of a class of securities quoted on ASX and may be subject to a subsequent offer for sale.

An Appendix 2A was lodged with respect to the Securities issued on 21 July 2025 and the Company hereby notifies ASX under s708A(5)(e) of the Corporations Act that:
