Answer: No. The Company has now completed the bulk sampling program at its Revere Gold Project and will require less funding than previous quarters for immediate work program commitments. As the Company is an exploration company and not generating any revenue it is expected that it will continue to have negative operating cash flows for the foreseeable future.

Answer: The Board is of the opinion that the Company has, or shall have access to, sufficient funds to meet its planned exploration activities and general working capital requirements.
