Answer:

The high costs associated with Pre-Feasibility Study (PFS) activities have now reduced following the completion of the program as at 30 June 2025. Further expenditure is expected to be incurred in the near term as the Bankable Feasibility Study (BFS) phase progresses.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

The Company received firm commitments for a \$1.282 million placement in June 2025, with \$424,519 received during the month and the balance expected in the following quarter. The Company will raise additional capital as required and have a strong track record of successfully securing funding when needed.

Answer:

Yes. The Company believes there is ongoing support for future capital raisings, which will allow the Company to continue its exploration activities.
