NuEnergy has a loan agreement with PT Indotech Metal Nusantara ("PTI"), a subsidiary of the ultimate parent company, GFB of IDR8,161,450,000 (\$A838,601) to fund part of the coal bed methane planned exploration activities. The loan has been fully drawn down in the past.
The conditions of the loan agreement with PTI are:-
1) Unsecured and repayable on demand*;

NuEnergy has loan agreements with AIC Corporation Sdn Bhd ("AICC"), a subsidiary of the ultimate parent company, GFB totalling \$A2,305,498 to fund part of the coal bed methane planned exploration activities and/or working capital. The loans has been fully drawn down in the past.
The conditions of the loan agreements with AICC are:-
1) Unsecured and repayable on demand*;
2) Loan shall be utilised for the drilling activities of the Production Sharing Contracts; and

1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

#### Answer:

NuEnergy is predominantly at the gas exploration stage and its operating cashflows will remain negative until it has completed exploration, evaluation and development phases on its projects prior to gas production revenue.

Until the generation of revenue from gas production, the Company is reliant on capital raising activities to fund its ongoing exploration and evaluation activities.

One of the Company's assets in Indonesia, which has obtained approval for its plan of development has embarked on an early gas sales initiative ("Early Gas Sales Initiative"), which targets initial gas sales of 1 million standard cubic feet per day ("mmscfd") to quickly begin monetising its assets. Under the Early Gas Sales Initiative, the Company has to-date, completed drilling and commenced dewatering for gas production for two of its four planned wells, spudded the third well and is undergoing drilling site preparation for its fourth well. In addition, as announced, the Company has signed a Heads of Agreement with PT Perusahaan Gas Negara Tbk ("**PGN**") for the sale and purchase of coal bed methane. PGN, listed on the Indonesia Stock Exchange, is a leading natural gas distribution and transportation player in Indonesia.

The amount of cash outflow during the exploration and evaluation stage of the remaining assets, depends largely on the extent of the drilling programs to be undertaken by NuEnergy. The drilling programs in turn can be managed or scaled in accordance to the financial strength of NuEnergy. Any decision to incur further drilling expenditure will depend on a few factors including but not limited to NuEnergy's cash position at the relevant time. As such, the operating cash flows will vary from quarter to quarter.

The Board continues to monitor cash flows to ensure the Company remains positioned to achieve its business objectives and will take the necessary action to raise capital to remain sustainable.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

#### Answer:

The Company has initiated steps to raise further cash to fund its operations. The Company will ensure the necessary release is made once funding is firmed and the decision is finalised and approved by the Board.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

#### Answer:

As stated in Item 2 above, the Company has initiated steps to raise further cash to fund its operations and in the event funding is delayed, NuEnergy has the option to modify its operations, exploration and development activities, if deemed necessary, whilst still achieving its business objectives. In addition, the Early Gas Sales Initiative is expected to generate some revenue for its operations.
