Orbital Corporation Ltd ('Orbital UAV', 'the Company') presents its quarterly activities report for the period ended 30 June 2025.

KEY HIGHLIGHTS:

- Operating cash outflow of \$0.5 million for the quarter.
- Cash, trade receivables and un-drawn loan facilities of \$5.9 million at 30 June 2025.
- Expenditure of \$1.2 million on product development during the quarter.
- This reflects the continued the development of a new larger capacity engine to meet the increasing market demand for higher UAV payloads.
- Prototype engines commence customer flight trials and evaluation during Q2 of 2025/26.
