REQUEST FOR TRADING HALT

Pinnacle Minerals Limited (**Pinnacle**) requests an immediate trading halt be granted by ASX in respect of its ordinary shares from the commencement of trading on 28 July 2025.

- a) The trading halt is requested pending an announcement in relation to a proposed capital raise;
