	1. Convertible Loan facility represents the Convertible Loan Facility Agreement with Smart East Global Limited ("SEGL") and Admiralty Resources (Hong Kong) Limited ("Admiralty HK")		
	As of the date of this report, the current Convertible Loan Facility agreement with SEGL has a maximum principal drawdown value of \$US2.93 million.		
	The current key terms of the facility are:		
	• The interest rate is 12% per annum. • Interest is payable quarterly in arrears. • The Conversion Price is 80% of the Volume Weighted Average Price ("VWAP") calculated 90 days immediately prior to the Conversion Date*; and • Maturity/expiry date of loan agreement is 31 December 2025.		
	* The Conversion Date is the date of receipt of a valid Conversion Notice.		
	2. The Company has a loan agreement (unsecured) with Shanghai Long Sheng Technology Development Co Limited. On the 1 July 2022, additional principal was extended to the Company of \$1,500,000 taking the total principal available under this facility to \$6,000,000.		
	The terms of the loan are:		
	• Principal loan available is \$AUD6,000,000. • Loan agreement date is 21 June 2018, second loan agreement signed on 1 July 2022 for a further \$1,500,000. • The interest rate is 5% per annum. • Interest is accrued and applied to the principal. • Maturity/expiry date of loan agreement: 31 December 2025.
