SNC Announces Fully Franked September Quarter Dividend

- SNC intends to pay a fully franked September quarter dividend of 1.4 cents per share on 5 September 2025
- SNC Shares continue to offer an attractive fully franked dividend yield of 6.6% (8.8% incl. franking)ⁱ
- Gross portfolio returns for FY2025 were 28.0%ⁱⁱ

The Directors of Sandon Capital Investments Limited (ASX:SNC) are pleased to announce their intention to pay a quarterly fully franked dividend of 1.4 cents per share. This represents an annualised rate of 5.6 cents per share. iii

This fully franked dividend represents an annualised yield of 6.6% (8.8% including franking).

The Dividend Reinvestment Plan (DRP) will apply to this dividend, with no discount. Director-related entities will participate in the DRP to varying degrees.

Performance Update

The 2025 financial year has delivered strong investment returns. The table below shows the various comparisons.

SNC has strong capacity to pay dividends

The Company has significant profit reserves. As of 30 June 2025, SNC has profit reserves totalling 40.8 cents per share and a franking balance of 7.5 cents per share. Based on the current franking balance, SNC has the capacity to pay 22.5 cents per share in fully franked dividends should the directors choose to do so. This equates to more than 4 years of dividends at the current rate of 5.6 cents per annum.
