

# **CLEANSING STATEMENT**

Almonty Industries Inc. ("Almonty" or the "Company") (TSX: AII / ASX: AII / NASDAQ: ALM / Frankfurt: ALI) has issued and allotted 333,333 CHESS Depositary Interests and 20,158,666 Common Shares ("Securities") as detailed in the Appendix 2A and Appendix 3G's announced on 18 July 2025.

## Secondary Trading Exemption:

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under Section 708 or 708A.
