**McGrathNicol Restructuring announces appointment of Voluntary Administrators to Resource Development Group Limited (Administrators Appointed) (ASX: RDG)  
ACN 149 028 142 and the entities listed at Annexure A  
(collectively, the Group)**

### **Appointment of Voluntary Administrators**

McGrathNicol Restructuring announces that Jason Ireland, Rob Brauer and Linda Smith were appointed voluntary administrators (**Administrators**) of Resource Development Group Limited (**RDG**) and six of its subsidiaries on 28 July 2025. A schedule of the entities over which the Administrators are appointed is provided at Annexure A.

The Administrators have assumed control of the Group's operations and intend to continue trading on a 'business as usual' basis while a sale and/or recapitalisation process is undertaken. This includes the operations at the Lucky Bay Garnet Project which will continue uninterrupted.

RDG's majority shareholder and secured creditor, Mineral Resources Limited (ASX: MIN) (**MinRes**), has offered to provide funding to the Administrators to support the continuation of trade through this period.

### **First meeting of creditors**

The Administrators will write to creditors shortly to advise of the details of the first meeting of creditors which is expected to be held on Thursday, 7 August 2025.
