## **Delisting from the ASX**

FTC's CHESS Depositary Interests (**CDIs**) will be suspended from trading at close of trade on 28 July 2025 and FTC will then be removed from the Official List of ASX at close of trade on 31 July 2025.

Following the Delisting, holders of CDIs (**CDI Holders**) will have their CDIs converted to the underlying Ordinary Shares in FTC, in accordance with the following process and indicative timetable.

CDN to transfer the title to the underlying Ordinary Shares to the former CDI Holder ( <b>Transfer of Title</b> ) and Company to cancel remaining CDIs.	Promptly following CHESS Holdings Conversion, but in any event no later than 31 November 2025 <sup>1</sup>
Company to issue to former CDI Holders share certificates in respect of Ordinary Shares.	Within 5 Business Days of Transfer of Title
