8.8.1	Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
	No. The Company does not expect to maintain the current level of net operating cash flows. Infinity has identified plans to explore the divestment of its Western Australian projects in response to changing market conditions in the resources sector. This strategy is intended to reduce fixed costs associated with the Western Australian tenements and free up additional cash resources. A number of the Company's assets in the Pilbara region are currently under due diligence, with divestment transactions expected to settle in the coming months.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

The Company successfully completed a pro-rata non-renounceable entitlement offer of New Options during the previous quarter, raising approximately \$282,010. These funds have now been received and form part of the current cash balance of \$321,000.

At this stage, the Company has not announced any new capital raising initiatives. However, it continues to actively monitor its cash position and funding requirements and is considering various funding options to support ongoing operations. The Board is confident that, if required, the Company would be able to raise additional capital through equity-based instruments or other funding avenues.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Yes. The Company expects to be able to continue its operations and meet its short-term business objectives on the basis of its current cash reserves of \$321,000 and ongoing cost management measures. While the estimated cash outflows exceed available cash over the next quarter, the Board is actively monitoring the Company's financial position and considering various funding options to support its operations beyond the current quarter. The Company is confident in its ability to secure additional capital through equity or other funding mechanisms, if required.
